Affiliate Membership shall be real estate owners and other individuals or firms who, while not engaged in real estate profession as a REALTOR®, have interests requiring information concerning real estate, and are in sympathy with the objects of the Association. Affiliate Membership shall also be granted to individuals licensed or certified to engage in real estate practice who, if otherwise eligible, do not elect to hold REALTOR® membership in the Association provided the applicant is engaged exclusively in a specialty of the real estate business other than a brokerage of real property.

Any member of the Association may be reprimanded, fined, placed on probation, suspended, or expelled by the Board of Directors for a violation of the Association's Bylaws and Rules and Regulations not inconsistent with the Association's Bylaws, after a hearing as provided in the Code of Ethics and Arbitration manual of the Association.
