Affiliate Membership shall also be granted to individuals licensed or certified to engage in real estate practice who, if otherwise eligible, do not elect to hold REALTOR<sup>®</sup> membership in the Association provided the applicant is engaged exclusively in a specialty of the real estate business other than a brokerage of real property.

Any member of the Association may be reprimanded, fined, placed on probation, suspended, or expelled by the Board of Directors for a violation of the Association's Bylaws and Rules and Regulations not inconsistent with the Association's Bylaws, after a hearing as provided in the Code of Ethics and Arbitration manual of the Association.
